# COVENTRY TOWNSHIP BOARD OF TRUSTEES Special Meeting of March 5, 2020

The Coventry Township Board of Trustees met in special session Thursday, March 5, 2020 at 12:15 p.m. in the Coventry Town Hall at 68 Portage Lakes Drive, Coventry Twp., OH 44319 to discuss the 2020 Permanent Appropriations, temporary use of Township property by Barbicas Construction to go into Executive Session to consider the purchase or lease of property for public purposes, (R.C. 505.10) and to discuss personnel matters, including appointment, promotion, dismissal and compensation of a public employee or official. The actual area they are requesting use of is outside of the fence, partially in the County's right-of-way.
