Re: Portage Lakes Water Main Extension

Dear Property Owner,

The Coventry Township Trustees and the City of Akron are pleased to inform you about a great opportunity! We have been collaborating to provide drinking water to portions of Portage Lakes where public water has not been previously available. With community involvement, the City of Akron seeks to provide drinking water at an affordable cost, especially to those with contaminated or low-service drinking water wells.

Many of the residents in the affected area attached have voiced concerns about their private water wells. In some instances, the circumstances are so severe that residents routinely do not have enough water from their well to wash clothes, take showers, or even flush their toilets. Public health concerns over well contamination are also present.

A Town Hall meeting will be held at the Coventry Community Center on March 14th, 2023, at 6:00 p.m. to discuss extending water service to the properties on the attached map, potential EPA funding, and expected costs to residents. The more residents interested in receiving public drinking water, the more equitable costs will be for each property owner.

WHERE DO WE GO FROM HERE?

The City of Akron has been diligently researching potential funding sources for the project and is in communication with Ohio EPA's Water Supply Revolving Loan Account (WSRLA) Program Staff. Because there are multiple homes relying on single wells, as well as a small Public Water Systems (PWS) that serve multiple residents in one complex, this project is eligible for EPA funding.

WHAT DOES THIS MEAN FOR ME?

This is great news for property owners along the proposed route of the water main extension. The City has set an estimated residential tap-in fee of \$5280 if at least half of property owners decide to connect. The City will also offer the option to finance this cost over 15 years at 1% interest per year resulting in a payment of approximately \$32/month. These costs are contingent on EPA funding. If you decline this offer now and request to tie in at a later date, you will not be eligible to benefit from the special financing terms provided from WSRLA. Your tap-in fee will be based on the City of Akron Tap-In Fee policies in place at the time of the request.

WHAT WE NEED FROM YOU NOW

Attached to this letter is a Property Owner Questionnaire. We ask you to complete this survey and return it in the prepaid envelope as soon as possible, or you may return by e-mail to the Project Manager at EThompson@akronohio.gov. By completing this questionnaire, you are not making a binding commitment at this time. This questionnaire allows us to seek funding. You may submit your questionnaire beforehand through mail, e-mail, or in person at the Township Administration Office.
